DEALER AGREES TO THE FOLLOWING TERMS:

1. Dealer setup time: Friday April 1st, 12:00pm (noon). Dealers Room Hours (Dealers will be admitted 30 minutes before the rooms will open to the public): Friday, 3:00 PM to 9:00 PM, Saturday 9:00 AM to 5:00 PM, Sunday 10:00AM to 5:00pm. Dealer agrees to remain set up during ALL dealers room hours.
2. Unless previously agreed to by StoogeCon, dealer agrees not to move tables, place anything in front of/or beside tables or interfere with any neighboring exhibits.
3. Any damage to the building by a dealer is the sole responsibility of the dealer. Solicitation of dealers and/or customers is strictly prohibited.
4. Dealer must be respectful of fellow dealers and visitors, including limiting the volume of any audio/video equipment.
5. No smoking or alcohol is permitted in the exhibit hall at any time.
6. Dealer understands payment policy and agrees to pay the fees as listed. No tables are guaranteed until payment is received.
7. If you must cancel, our refund policy is as follows: Cancellation prior to March 1, 2016 will be eligible for a full credit or refund. Cancellations made after March 1, 2016 will NOT be eligible for refund.
8. Subletting is not allowed without the consent of StoogeCon.
9. Sharing of tables is not allowed without the consent of StoogeCon. If approved, the person whose name appears on this contract assumes full responsibility for the table(s).

**INDEMNIFICATION AND HOLD HARMLESS AGREEMENT**

This INDEMNIFICATION AND HOLD HARMLESS AGREEMENT (“Agreement”) is

1. As part of the Three Stooges Convention on April 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup>, 2016, Sponsors are providing Exhibitor with a venue for the display, trade and/or sale of certain memorabilia. Exhibitor warrants to Sponsors that the activities conducted at the Convention, and the memorabilia displayed, traded and/or sold at the Convention shall not be fraudulent or involve the sale of counterfeit or stolen items; infringe on any third party’s copyright, patent, trademark, trade secret or other proprietary rights of publicity or privacy; be defamatory, trade libelous, unlawfully threatening, unlawfully harassing or obscene.
4. Exhibitor agrees to indemnify and hold Sponsors harmless from any claim or demand, including attorneys’ fees, made by any third party due to or arising out of Exhibitor’s breach of this Agreement or Exhibitor’s violation of any law or the rights of any third party. Exhibitor acknowledges it is solely responsible for any damage to hotel property caused by the Exhibitor.
